THE FUNDED RESEARCH IS AIMED AT INVESTIGATING THE UNDERLYING CAUSES OF AUTISM INCLUDING BIOCHEMISTRY AND NEUROLOGY AS WELL AS DEVELOPING AND VALIDATING TREATMENT EFFECTIVENESS. GAC HAS SPONSORED MANY CONFERENCES AND OUTREACH SERVICES. IN THE PAST TWO YEARS, THIS HAS INCLUDED COLUMBIA, GHANA, INDIA, THE PHILIPPINES, RUSSIA, AND THE UKRAINE.
